Our Teacher Salary Scale

At E.L. Haynes we deeply value the experiences that our teachers bring into the classroom each day. Our Teacher Salary Scale incorporates all of your prior years of relevant teaching experience. When you join our community, we honor every year of teaching experience, and as you stay with us over time, you will continue to see predictable annual increases.

Teaching Experience - What Counts

- Teaching experience in a Pre-K through 12 school setting (in the US or in an international school)
- Instructional leadership in a Pre-K through 12 school setting
- Instructional support experience at E.L. Haynes (*Note: this experience will be prorated, e.g. 0-2 years of experience will be placed on Step 1, and 3-5 years will be placed on Step 2*)

Teaching Experience - What Doesn't Count

- Less than 50% of a school year
- Tutoring experience
- Daycare experience
- Volunteering
- Homeschool teaching experience
- University- or College-level teaching experience
- Resident, fellow, and/or student-teaching experience
- Substitute teaching
